Several executors or administrators of a deceased member in whose name any share stands shall for this purpose be deemed joint holders thereof.
- To be valid, this proxy form together with any power of attorney or other authority (if any) under which it is signed or notarially certified copy thereof must be lodged with the registered office of the Company at 7th Floor, Goldlion Holdings Centre, 13-15 Yuen Shun Circuit, Siu Lek Yuen, Shatin, New Territories, Hong Kong not less than 48 hours before the time for holding of the Meeting or adjourned meeting (as the case may be).
- A proxy needs not be a member of the Company.
- Completion and delivery of this form of proxy will not preclude you from attending and voting at the Meeting or at any adjournment thereof if you so wish.
- Any alteration made to this proxy form must be initialled by the person who signs it.
